The Quest for a Seamless System

during your first year of office?" "Developing good operational processes and digital infrastructure," was one of my answers. 1 ½ years in, the journey to build a seamless system continues. As my office has ramped up our presence in the community, so has our email volume and by extension the number of cases that need to be managed. Previously the city provided councillors with a CRM. This stopped because the software became outdated. Currently, councillors receive \$4000 per year towards a CRM and case management system. To best serve you, a councillor's office needs many tools depending on their goals and operational model. Here are the types of services my office uses:

• CRM

- Case ManagementEmail delivery service
- Website/Domain Hosting
- Event Management/Ticketing
- Web conference tool (eg. Zoom)Survey tool
- Team Communications (Eg. Cliq)
- Civic engagement tool (Eg. Citizen Lab)

- Unlike other city divisions, councillors own our own data. This presents some challenges as our data infrastructure is locked outside of the city's infrastructure.

processes. It does not make sense that every councillor has to invent our own data infrastructure with many make-shift patches across systems because we do not have the budget to create the suite of tools we need. I think we could reduce costs and provide better service if the city worked with councillors on developing more integrated tools where the data could continue to be segmented for councillors to own, but points of intersection could be developed as needed - for example with 311 case information. We have already come a long way in optimizing our suite of tools, but there is much work that still needs to be done to be better at tracking data and closing the loop on the vast number of emails we receive. - All members were thoroughly engaged in each others' proposals and participated eagerly in the Q&A at the end of each presentation, challenging and encouraging each other. We were incredibly impressed by the creativity and

passion of these young leaders and are excited to see their visions materialize through the Youth Council.

After a full afternoon of speeches, Youth Council members cast votes to

determine the council's first President and Vice-President. The Willowdale Youth Council elected Brandon Woo, a Grade 10 student at Earl Haig Secondary School, as its inaugural President, who proposed the idea of connecting our community through exercise. Dahlia Zarrabian was elected as Vice-President.

The council will reconvene in a month at the May meeting to elect its remaining executive members and listen to more solutions for positive change in Willowdale. Congratulations to Brandon and Dahlia!

The challenge with this committee is the breadth of work that needs to be covered. The Toronto Police Service is the fourth largest municipal police service in North America.

5 Officers Injured Last Month. During the board meeting we were informed of five officers injured in the line of duty - one of whom is a 32 Division officer who was injured in a carjacking arrest in our neighbourhood. We offer our sincere

gratitude to all officers who put their lives at risk every day for the safety of our city - especially those who have endured injury as a part of the work!

Improved Priority One Response Time. Back in February, the Priority One (lives are endangered) response time was 22 minutes. The Chief reported that despite call volume rising by 1000 calls (year to date), the response time for the past 4 weeks has been 18 minutes on average. This is still long compared to the

12.8 minutes response time in 2010, but the improvement is much appreciated.

The Chief attributes these improvements to the stability in the pipeline of

bringing onboard new recruits supported by the recent budget. We are hopeful as TPS puts together a multi-year hiring plan that the pipeline of new recruits will continue to strengthen our police service, especially as 25% of officers are currently eligible for retirement.

An apology from the Chief. Many were upset by Chief Demkiw's remarks made in response to the not-guilty verdict in the Umar Zameer trial. He apologized for his choice of words at the meeting. He said, "Closure can never come at the expense of justice. I should have been more clear in my support of the verdict," and committed to full transparency as the OPP investigates the review of the trial and the actions taken by the officers who participated in the trial.

Building trust with Indigenous communities in the collection of Race-Based Data. In its ongoing efforts to foster trust and transparency, TPS is actively working with community stakeholders to collect and analyze data towards improving equity and accountability. A representative from the Indigenous Community shared how most of their community has not felt safe to participate with the ongoing study due to ethical practices in research and lack of clarity in data ownership. If reconciliation is a priority, our efforts to engage Indigenous communities cannot be cursory but must be meaningful and intentional. We must cross the divide to build trust. As such, I moved the following motion with full support of the board. This motion is proof that making deputations can make a difference in the policies that are made.

Indigenous Engagement, consult with the Indigenous communities to be included in the current Race-Based Data Collection Policy review and includes an update that incorporates ethics in research and data ownership with a report back with the report from the review. governing policing in the province resulted in new legislation coming into effect on April 1. This Act was passed in 2019 and only being implemented now due to many consultations that had to happen before the Act was finalized. online course, including quizzes, to ensure we are apprised of recent changes to provincial policing policy and how it relates to our role as board members. Part of the Act states that board members cannot be former officers in the

service they are governing. As such, we had to say farewell to Councillor Jon Burnside, who used to be a Toronto police officer. He has been replaced by Councillor Shelley Carroll, who brings a wealth of experience from previously serving on this board.

The Implications of Bill 185 In the previous month, the Government of Ontario brought forth Bill 185, known

as the Cutting Red Tape to Build More Homes Act. This comprehensive legislation encompasses modifications to various laws, including alterations to development charges and Ontario's land-use planning framework. The primary objective is to eliminate obstacles and facilitate the construction of 1.5 million homes by 2031.

While Bill 185 will make significant steps towards restoring municipalities' ability

- some advocates feel that Bill 185, the "Cutting Red Tape to Build More Homes

Act, 2024," if passed, will significantly undermine community engagement, dismiss ongoing appeals against inequitable developments, reduce municipal oversight, and threaten the sustainability of neighbourhoods. I know many community members are already shocked to discover their input

has very little impact on development proposals. Here are some key concerns highlighted by the Coalition for Equitable and Inclusive Development: Reduced Community Engagement: Bill 185 aims to eliminate public

- input on development projects and diminish our role in crucial planning decisions that adversely impact our livelihoods and our communities. Public participation in land use planning and development is essential and should be encouraged, not eliminated. • Dismissal of Existing Appeals: Bill 185 proposes to disregard any current community appeals against developments, eroding our efforts to
- advocate for just and inclusive urban planning. • Limited Municipal Oversight: The proposed legislation will strip local municipalities of their ability to consult on major planning applications, weakening the influence of community stakeholders in safeguarding
- community interests. • Encroachment on Green Spaces: The enactment of this bill poses a risk to greenbelt areas and could undermine efforts to ensure that new developments include necessary community benefits and support
